ARTICLE I. NAME AND ADDRESS

The name and address of this corporation shall be A.B. ENTERPRISES OF PASCO COUNTY, INC., 5006 TROUBLE CREEK ROAD, SUITE 114, NEW PORT RICHEY, FL 34652.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Department of State. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE
