ARTICLES OF INCORPORATION

OF

HENDRIX, SITES AND NEAVES, P.A.

I, the undersigned subscriber to these Articles of Incorporation, am a natural person competent to contract, and do hereby associate ourselves together for the purpose of forming a professional corporation under the laws of the State of Florida.

ARTICLE 1

The name of this professional corporation is: Hendrix, Sites & Neaves, P.A.

ARTICLE II

The general nature and purpose of this professional corporation shall be to engage in every aspect of the general practice of law. The professional services involved in this corporation's practice of law may be rendered only through its officers, agents and employees who are duly authorized and licensed to practice law under the laws of the State of Florida. This professional corporation may also operate a general business and other related business, and to buy, hold, or otherwise acquire, mortgage, sell, convey, lease or otherwise dispose of real and personal property, and to purchase, or otherwise acquire, own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, wares, merchandise, real and personal property and services of every class, kind and description, to contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporate indebtedness as required, except that it is not to conduct a banking, safe deposit, trust, insurance surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

ARTICLE III

The aggregate number of shares of stock that this corporation is authorized to issue One Hundred (100) shares of \$1.00 par value common stock.

ARTICLE IV

The street address of the registered and principal office of this corporation are 707 North Franklin Street, Suite 750, Tampa, Florida 33602 and the name of the initial registered agent of this corporation at that address is David S. Hendrix. This principal office and registered office addresses are the same.

ARTICLE V
