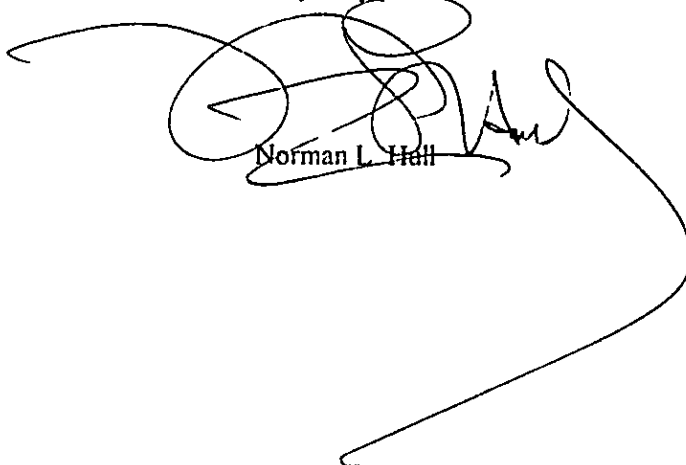

ARTICLES OF INCORPORATION  
OF TRAVEL COUNTRY RV CENTER, INC.

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, hereby certifies as follows:

ARTICLE I

The name of the corporation shall be TRAVEL COUNTRY RV CENTER, INC.

ARTICLE II

The corporate existence shall begin upon the filing of these Articles by the Department of State of the State of Florida. The duration of the corporation shall be perpetual.

ARTICLE III

This corporation is formed for the purpose of engaging the purchase, marketing, sale and resale of recreational vehicles and any and all related business activities. This corporation may also engage in any lawful business for which a corporation may be incorporated under the laws of the State of Florida. This corporation shall have and may exercise any and all powers necessary or convenient to carry out any business in which it may be engaged, and it shall additionally have and may exercise any powers necessary, convenient or incidental to the carrying out of any such business.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is one hundred (100), having a par value of One Dollar (\$1.00) per share.

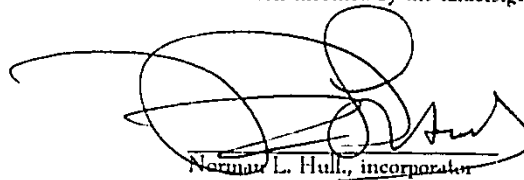
#### ARTICLE VII

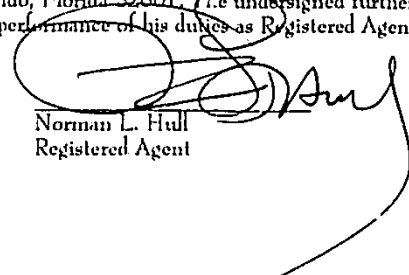
