We the undersigned natural person of the age of twenty-one years or more, acting as incorporators of a corporation under the Florida Statute Corporation Act, adopt the following Articles of Incorporation for such corporation.

The name of the corporation shall be Zsolt Novaczky, Inc.

The initial principal office address is 18566 N.E. 18th Avenue #211  
North Miami, Dade County, Florida 33179

The registered office of the corporation shall be at 18566 N.E. 18th Ave. #211,  
Miami, Florida 33179, and the name of the initial registered agent at

agent may be changed in a manner provided by law.

The Corporation is authorized to issue one class of stock. The amount of the total number of such  
shares is 1000 shares of common stock, and the par value is \$ .01 per share. The number

Regulatory provisions. The following additional provisions are inserted for the management of the  
business and for the conduct of the affairs of the Corporation. (a) Power of Directors to amend  
bylaws. The Board of Directors is authorized and empowered from time to time in its discretion  
to make, alter, or repeal the bylaws of the Corporation. (b) The unanimous vote of all directors is  
required for any business transaction at any meeting of directors.

Preemptive rights. No holder of any stock of the Corporation shall be entitled, as a matter of right, to purchase, subscribe for, or otherwise acquire any new or additional shares or stock of the corporation of any class.
