THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1

NAME

The name of this corporation is Audio Engineering, Inc. The principe' rlace of business is 804 S. Palafox Street, Pensacola, Florida 32501.

ARTICLE II

DURATION

The duration of this corporation is perpetual.

PURPOSE
