ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Two Brothers Seafood, Inc. and its address is 201 20th Street Ocean, Marathon, Florida 33050.

ARTICLE II

DURATION

The corporation shall commence existence on January 2, 1997. The duration of the corporation is perpetual.

ARTICLE III

PURPOSE

The general purpose for which the corporation is organized are:
