The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

#### NAME

The name of the corporation is Miss Kathy Ann, Inc. and its address is 201 20th Street Ocean, Marathon, Florida 33050.

#### ARTICLE II

### DURATION

The corporation shall commence existence on January 2, 1997. The duration of the corporation is perpetual.

### ARTICLE III

### **PURPOSE**
