The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

EFFECTIVE DATE
12-30-94

ARTICLE I
NAME

The name of the corporation shall be: **TRaC SERVICES, Inc.**

ARTICLE II
OFFICES

The principal offices of the Corporation in the State of Florida shall be located in Jacksonville, County of Duval. The Corporation may have other such offices within or without of the State of Florida as the Board of Directors or business of the Corporation may require. The initial address shall be 10463 Osprey Nest Dr W., Jacksonville, Florida 32257.

ARTICLE III
SHAREHOLDERS

Section 1. The Corporation shall issue 1000(One Thousand) shares of stock at no par value initially. The board of Directors, by resolution, may from time to time, direct the issuance of additional shares of stock.

Section 2. The Board of Directors will establish by resolution and cause to be recorded in the minutes of the Corporation all pertinent information as to Annual and Special Meetings, Notification of such meetings, Quorum requirements, Voting lists and rights and Proxie utilization.

OFFICERS**

The Corporation shall have, as a minimum, three officers. These officers shall be the President, Vice President and Secretary/Treasurer. Other officers may be appointed by the Board of Directors as deemed appropriate, by resolution. The officers shall be the directors.

**ARTICLE VI
CONTRACTS, LOANS, CHECKS AND DEPOSITS**

Section 1. Contracts: The Board of directors may authorize any officer or appointed agent to enter into any contract or deliver any instrument in the name of and on the behalf of the Corporation, and such authority may be general or confined to specific instances.

Section 2. Loans: No loans or indebtedness shall be contracted on behalf of the Corporation unless authorized by resolution of the Board of Directors.

Section 3. Checks, Drafts, Deposits, etc.: All instruments shall be signed by officers or agents as specified by resolution by the Board of Directors. All funds of the Corporation not otherwise employed shall be deposited from time to time to the credit of the Corporation in such banks, trust companies or other depositories as the Board of Directors may select.
