ARTICLE IV AMENDMENT DATE

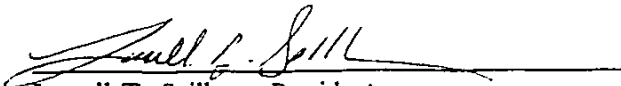
This amendment was adopted on the 23rd day of January, 1997.

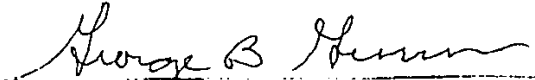
