Florida Statute 607.1003(6) provides "Unless otherwise provided in the articles of incorporation, the shareholders of a corporation having thirty-five (35) or fewer shareholders, may amend the articles of incorporation without an act of the directors at a meeting for which notice of the changes to be made is given." These Articles of Amendment are made pursuant to this chapter and section of the Florida Statutes.

FIRST: Article X, Pre-Emptive Rights. This article pertaining to pre-emptive rights is deleted in its entirety, thereby removing pre-emptive rights from each and every shareholder.

SECOND: The date on which this amendment was adopted: June 25, 1997.
