RESOLVED FURTHER, that Articles of Dissolution will be prepared and filed with the Secretary of State of the State of Florida as soon as practicable.

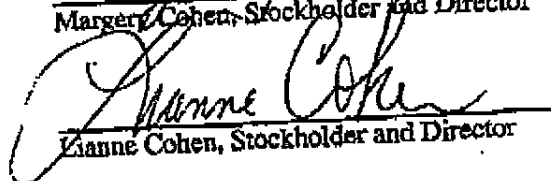
