I, the undersigned, do hereby make, subscribe, acknowledge, and file these Articles of Incorporation for the purpose of incorporating SCOTT COMMUNICATIONS, INC. (the "Corporation"), under the Laws of the State of Florida.

## ARTICLE I

NAME - The name of the Corporation is: SCOTT COMMUNICATIONS, INC.

# ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS - The Corporation's principal office shall be located at 11104 Wildlife Trail, Tallahassee, Florida, and its mailing address shall be 11104 Wildlife Trail, Tallahassee, Florida, 32312.

## ARTICLE III

TERM OF EXISTENCE - This corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation with the Florida Department of State.

## ARTICLE IV
