The undersigned incorporator, being over the age of eighteen years, hereby forms and establishes a corporation under the Florida General Corporation Act (the "Act").

ARTICLE I

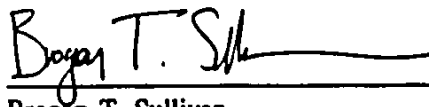
