TALLAHASSEE**ARTICLES OF INCORPORATION****TO: SECRETARY OF STATE, STATE OF FLORIDA, TALLAHASSEE, FLORIDA**

I, the undersigned natural person of the age of twenty-one or more, acting as incorporator of a corporation under title 607.164, of the LAWS of the State of Florida, adopt the following Articles of Incorporation for such corporation.

1. The name of the corporation, hereinafter referred to as the Corporation, shall be Austrian Technology & Systems Inc.
2. The duration of the Corporation shall be perpetual.
3. The object and purpose for which the Corporation is formed is to engage in the ownership and management of a marketing sales and technical support business and any other business permitted by law.
4. The aggregate number of shares which the Corporation is initially authorized to issue is one thousand (1000). There shall be one class of stock with a par value of one dollar(\$1.00). There shall be no preferences, qualifications, limitations, restrictions or special rights with respect to the one class of stock.

6. Provisions for the regulation of the internal affairs of the Corporation are contained in the By-Laws of the Corporation.

8. The initial registered office and principal place of the Corporation shall be located at: 8720 Wendy Lane South West Palm Beach, FL 333411. The initial registered agent is Richard P. Vajna.
9. The following person shall constitute the initial Board of Directors of the Corporation, and shall serve until the first annual meeting, or until, their successors shall be elected: Richard P. Vajna who resides at 8790 Wendy Lane South, West Palm Beach, FL 33411.
10. The incorporator of this corporation is Richard P. Vajna, who resides at the address stated in Paragraph 9.
