ARTICLE 1

NAME

The name of this corporation is: American Nursery Label, Inc.

ARTICLE 2

DURATION

The duration of this corporation is perpetual. The date and time of commencement of the corporate existence is January 1, 1997.

The number of directors may be changed from time to time by the bylaws.


