Pursuant to Section 607.1007 of the Florida 1989 Business Corporation Act, American Nursery Label, Inc. (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation to change the name of the Corporation.

FIRST: The name of the Corporation is American Nursery Label, Inc.

SECOND: ARTICLE 1 of the Articles of Incorporation of the Corporation is amended to read in its entirety as follows:

"ARTICLE 1

NAME

The name of this corporation is: Horticultural Printers-Florida, Inc."

THIRD: The date of the adoption of the amendment is May 15, 1998.

FOURTH: The amendment was approved by the sole shareholder of the Corporation. The number of votes cast for the amendment was sufficient for approval.
