ARTICLES OF INCORPORATION

HIGH SPRINGS PLAZA, INC.

The undersigned, for the purpose of forming a corporation for profit under Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

- Section 1.1 Name. The name of the corporation is High Springs Plaza, Inc..
- Section 1.2 Address. The principal office and mailing address of the corporation shall be 4347-4 University Boulevard South, Jacksonville, Florida 32216.

ARTICLE II

TERM OF EXISTENCE
