ARTICLES OF INCORPORATION
MEDICAL TECHNOLOGY MANAGEMENT, INC.

ARTICLE I - NAME AND ADDRESS

The name and mailing address of the Corporation Medical Technology Management, Inc. and 2016 W. Bay Drive Miami Beach, Florida 33141 respectively.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

ARTICLE IV - CAPITAL STOCK

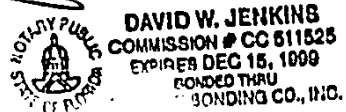
