ARTICLE I

NAME

The name of this corporation is THE MASTER'S GARDENER, INC.

ARTICLE II

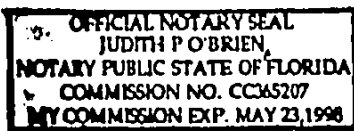
