## ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of this corporation is "KEN-LEY, INC.". The principal location of the corporation is 101 Mariner Drive, Ormand Beach, Florida 32176.

## ARTICLE II - DURATION

This corporation shall have perpetual existence.

## ARTICLE III - PURPOSE
