# ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: JON'S RETIREMENT HOME, INC., 1249 Suwanee Road, Daytona Beach, Florida 32114.


