**ARTICLE I - NAME**

The name of the corporation is A BRIDE ABOVE THE REST, INC.

**ARTICLE II - DURATION**

This corporation shall exist perpetually commencing on the date of execution and acknowledgement of these Articles.

**ARTICLE III - PURPOSE**
