The undersigned incorporator for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the Corporation is Your Good Health Network, Inc. (the "Corporation").
- SECOND:** The initial street address of the principal office of the Corporation is unknown; however, the mailing address of the Corporation is 10323 El Caballo Court, Delray Beach, Florida 33446.
- THIRD:** The Corporation is authorized to issue 7,500 shares of common stock, par value \$.01 per share.

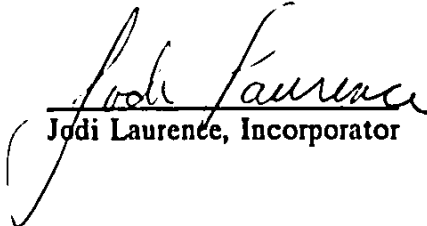

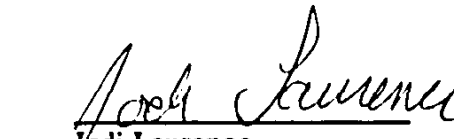
TENTH: The corporate existence of the Corporation shall commence upon filing of these Articles of Incorporation.
