ARTICLE I NAME

The name of the corporation shall be **HARTMAN WOODWORKS, INC.**

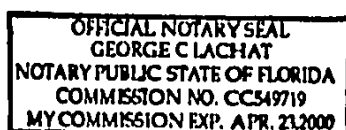
