THE UNDERSIGNED, acting as sole incorporator of a professional service corporation to be formed under the provisions of Chapter 607, the Florida Business Corporation Act, and Chapter 621, the Florida Professional Service Corporation Act, of the Florida Statutes, adopts the following Articles of Incorporation.

Article I: Name of Corporation. The name of the corporation (the "Corporation") shall be: Joel H. Schechter, P.A.

Article II: Office and Address. The address of the principal office and the mailing address of the Corporation is:

3001 Tamiami Trail North

Article III: Purpose. The purpose of the Corporation is to engage in the practice of law and to do such other acts as may be permitted by law for a professional service corporation engaged in such a practice.

Article IV: Shares. The Corporation shall have authority to issue 1,000 shares of common stock, par value one cent (\$.01) per share.

Article V: Registered Office and Agent. The street address of the initial registered office of the Corporation is 3001 Tamiami Trail North, Naples, Florida 34103, and the name of its initial registered agent at such address is Joel H. Schechter.

Article VI: Directors.
