SECTION I: To clean, press, renovate, repair, dye, finish and otherwise service fabrics and wearing apparel of all kinds, and in general to engage in the cleaning and dyeing business in all of its phases and to manufacture, produce, buy, hold, sell, and deal in all materials, equipment, and personal property appurtenant or incident to and useful in the cleaning and dyeing business.

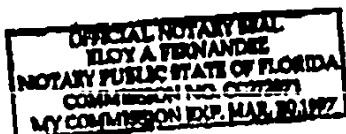
