The undersigned, acting as the incorporator of a corporation under the Florida Business Corporation Act adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is Site Systems, Inc..

ARTICLE II. COMMENCEMENT AND DURATION OF CORPORATE EXISTENCE

Corporate existence shall commence on the date the Articles are filed by the Department of the State and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III. CAPITAL STOCK

This corporation shall have authority to issue ten thousand (10,000) shares of Capital Stock with a par value of \$1.00 per share. The shares of the corporation are not to be divided into classes.


