## ARTICLES OF INCORPORATION

## UNIVERSITY OF ST. AUGUSTINE REAL ESTATE CORPORATION

The undersigned, for the purpose of forming a cofphraction under the Florida General Corporation Act, do hereby apopt the following Articles of Incorporation:

Article 1. Name and Address. The name of The Corporation is: UNIVERSITY OF ST. AUGUSTINE REAL ESTATE CORPORATION and its address is: 170 Malaga Street, St. Augustine, FL 21084.

Article 2. Duration. The duration of the Corporation is perpetual.
