ARTICLES OF DISSOLUTION  
OF  
OF ROHATGI INVESTMENTS, INC.

Pursuant to the provisions of Section 607.1401 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

Article I - Name of Corporation

The name of the corporation is Rohatgi Investments, Inc. (hereinafter referred to as the "Corporation").

Article II - Date of Formation

The date of filing of the Corporation's Articles of Incorporation was January 6, 1997.

Article III - Approval of Dissolution
