OF

The undersigned, acting as incorporators of a corporation under the Florida General Corporations Act, adopts the following articles of incorporation for such corporation.

ARTICLE I - NAME: The name of the corporation is Dixie L. Kist, P.A.

ARTICLE II - PURPOSE: This corporation is organized for the purpose of conducting all business or activities legally permitted under the laws of the United States and the State of Florida.

ARTICLE III - DURATION: The period of the duration of the corporation is to be perpetual.

ARTICLE IV - CAPITAL STOCK: This corporation is authorized to issue 100 shares of common stock of no par value.

ARTICLE V - INITIAL REGISTERED OFFICE The street address of the initial registered office of this corporation is 12 South Orlando Avenue, Kissimmee, Florida 34741-5674, and the name of the initial registered agent is Dixie L. Kist.

ARTICLE VI - SHAREHOLDER MANAGEMENT: This corporation shall not have a Board of Directors, but shall be managed directly by or under the direction of the shareholders.


