ARTICLES OF INCORPORATION

The undersigned, acting as Incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. NAME. The Name of the corporation is LOWRY FINANCIAL SERVICES, INC.
- 2. ADDRESS. The initial address of the principal office, business office address and mailing address of the corporation is:

- 3. DURATION. The period of its duration is perpetual.
- 4. PURPOSE. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

- 9. AMENDMENT OF ARTICLES. This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
- 10. VOTING TRUSTS: No shareholder of this corporation shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his shares.
- 11. CUMULATIVE VOTING FOR DIRECTORS: At all elections of directors of this corporation, each stockholder shall be entitled to as many votes as shall equal the number of votes which (except for these provisions as to cumulative voting) he/she would be entitled to cast for the election of Directors with respect to his/her shares of stock multiplied by the number of directors to be elected, and he/she may cast all such votes for a single director, or may distribute them among the number to be voted for, or any two or more of them, as he/she may see fit.
- 12. RESTRAINT ON ALIENATION: The shareholders of this corporation shall have the power to include in the By-Laws, adopted by a majority of the shareholders of this corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding shares of this corporation by any of its shareholders, or in the event of the death of any of its shareholders. The manner and form, as well as relevant terms, conditions, and details hereof, shall be determined by the shareholders of this corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice thereof, unless existence of such provisions shall be plainly written upon the certificate evidencing the ownership of such stock. No shareholder of this corporation my sell or transfer his/her shares therein, except to another individual who is eligible to be a shareholder of this corporation and only after securing written approval of the other shareholders, which shall not be unreasonably withheld.
