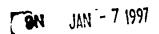

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE ONE NAME

The name of the corporation is IMAGES ON THE GO, INC.

The term of duration of the corporation is perpetual.
