#### ARTICLES OF INCORPORATION

THE UNDERSIGNED, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

#### **ARTICLE I**

Name

The name of the corporation is Noran Investments, Inc.

### **ARTICLE II**

Duration

The period of existence of the corporation is perpetual.


