**ARTICLE I
NAME**

The name of this Florida corporation shall be **IBT ENERGY SERVICES, INC.**
(the "Corporation").

**ARTICLE II

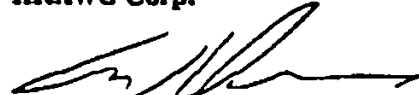
