Article I Name

Article II Principal Office

Article IX

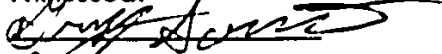

These articles of Incorporation will have an effective date of January 1, 1997.

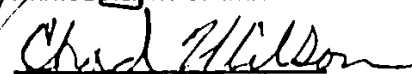
