

Dream Weddings Corporation

Article I Name

The Name of the corporation is "Dream Weddings Corporation"

Article II Principal Office

The Principal place of business and mailing address of this corporation shall be: 687 Ashford Oaks Dr. # 202, Altamonte Springs, FL 32714

Article III Shares

This corporation is authorized to issue 1000 shares of ONE DOLLAR (\$1.00) par value common stock, which shall be designated as "common Shares".

Article IV Initial registered agent and street address

The name and address of the initial registered agent is:

Article V Incorporators

The corporation shall have one (1) director initially. The name and address of the initial board or Directors are: Dino Vincent Soriano Sr., 687 Ashford Oaks Dr. #202, Altamonte Springs, FI 32714, President, Vice president, treasure and Secretary.

The Number of Directors may be increased from time to time in a manner provided by the by-laws. Members of the first Board of Directors shall serve until their successors are elected of appointed and have qualified.

These articles of Incorporation will have an effective date of January 1, 1997.
