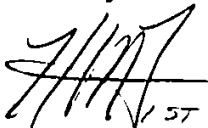

The undersigned subscriber to these Articles of Incorporation, being a natural person, competent to contract, hereby forms this corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is Steiger Chiropractic Center, P.A..

ARTICLE II

NATURE OF BUSINESS

The purpose of the corporation is to practice the profession of chiropractic medicine. The sole and exclusive professional service to be rendered by the corporation is chiropractic medicine.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at one time is 50 shares of common stock having a par value of \$100.00 per share.

ARTICLE IV

INITIAL CAPITAL

The amount of capital with which this corporation will begin business is not less than \$500.00.

ARTICLE V
TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI
ADDRESS

The initial post office address of the initial principal office of this corporation in the State of Florida is 995 Highway 77, Suite 3, (Post Office Box 979) Chipley, Florida . The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida.

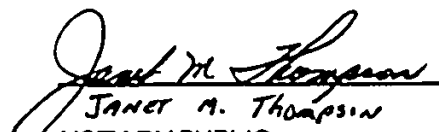
AMENDMENT
