ARTICLES OF INCORPORATION

OF
TOTAL CARE CONCEPTS, INC.

ARTICLE I - NAME

The name of this corporation is TOTAL CARE CONCEPTS, INC.
Highway 20 East, Bristol, FL 32321.

This corporation is to have perpetual existence.

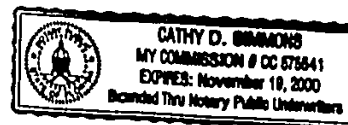
