#### ARTICLES OF INCORPORATION

OF

# 84 SUPREME ENTERPRISES. INC.

I, JOSE MARIO SUAREZ, being of legal age, do hereby sign these presents for the purpose of forming a corporation under the laws of the State of Florida authorizing the formation of corporations.

#### ARTICLE I.

The name of the corporation shall be:

#### ARTICLE II.
