OF

ARTICLE ONE

The name of the corporation is **R.S. KIDWELL, INC.** The principal address of the corporation is: 1139 N.E. 18th Avenue, Fort Lauderdale, Florida 33304.

The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) of no par value.


ARTICLE FIVE
