
ARTICLE IX



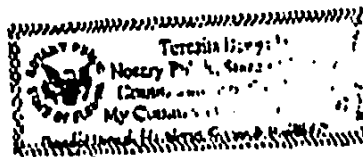
