ARTICLES OF INCORPORATION OF MACVEAN'S MOBILE MARINE, INC.

SECRETARY OF STATES OF STA

Article 1 Name

The name of this corporation is:

MACVEAN'S MOBILE MARINE, INC.

Article 2 Duration: Effective Date

This corporation shall exist perpetually, commencing January 1, 1997.

Article 3 Purposes

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

Article 4 Capital Stock

This corporation shall be authorized to issue One Hundred Thousand (100,000) shares of Common Stock, each having a par value of One Cent (\$.01).
