ARTICLE I

The name of this corporation is Y V, Inc. The principal office and/or mailing address of this corporation is as follows: 3162 Matecumbe Key Road, Punta Gorda, Florida 33955.

ARTICLE II

This corporation is organized for the following purposes: To carry on any business, occupation, undertaking or enterprise and to exercise any power or authority which may be done by a private corporation organized and existing under and by virtue of Florida Statutes, Chapter 607 (1995), it being the intention that this corporation may conduct and transact any business lawfully authorized and not prohibited by Florida Statutes, Chapter 607, (1995).

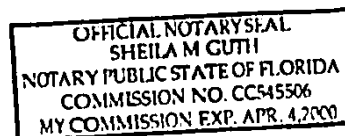

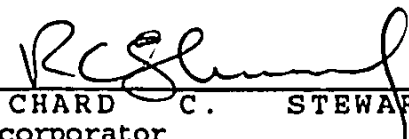
