ARTICLE I - NAME:

The name of this corporation is: J. KEN DUKES AGENCY, INC., hereinafter referred to as the ("Corporation").

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing at 1:01 A.M., January 1, 1997.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the Insurance Sales business and for the purpose of transacting any or all other lawful business not inconsistent with the Laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK:

The Corporation is authorized to issue 100,000 shares of One Dollar (\$1.00) par value common stock.

ARTICLE V - PRE-EMPTIVE RIGHTS:


ARTICLE IX - BY-LAWS:


