ARTICLES OF INCORPORATION

OF

MEADOW CLUB APARTMENTS, INC.

ARTICLE I

The name of the corporation is MEADOW CLUB APARTMENTS, INC. and its mailing address and principal place of business is 899 West Cypress Creek Road, Suite 812, Fort Lauderdale, Florida 33309.

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The corporation is organized for the purpose of the transaction of any and all lawful business for which corporations may be incorporated, pursuant to Chapter 607, Florida Statutes, known as the Florida Business Corporation Act.

ARTICLE X


