

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

## ARTICLE I

### Name of Corporation

The general nature of the business to be transacted by this corporation is restaurant as well as any other activities of business permitted under the laws of the United States and the State of Florida.

## **ARTICLE XII**


### **Pre-Emptive Rights**
