



**ARTICLES OF INCORPORATION OF
HAMA ENTERPRISES USA, INC.**

ARTICLE I-NAME

The name of this corporation is HAMA ENTERPRISES USA, INC.


ARTICLE IX - INDEMNIFICATION

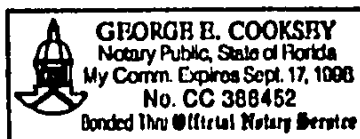
