## ARTICLES OF INCORPORATION

OF

## HOME DESIGN DEPOT, INC.

### ARTICLE I

NAME: The name of the corporation is HOME DESIGN DEPOT, INC

## ARTICLE II

DURATION: The term of existence of the corporation is perpetual.

### ARTICLE III

PURPOSE: The purpose of the corporation is to engage in any and all lawful business.

### ARTICLE IV

CAPITAL STOCK: The aggregate number of shares that the corporation has authority to issue is 1,000, all of which shall be common shares with a par value of \$1.00. The board of directors may, from time to time, detrmine the consideration for all classes and series of shares.
