ARTICLES OF AMENDMENT
OF
EBI OF NORTH FLORIDA, INC.
(DOCUMENT NUMBER: P97000001979)

The Articles of Amendment of EBI OF NORTH FLORIDA, INC. are as follows:

1.

The name of the corporation is EBI OF NORTH FLORIDA, INC. (the "Corporation") and its document number is P97000001979.

2.

The Articles of Incorporation of the Corporation as heretofore granted by the Secretary of State of the State of Florida on January 7, 1997, are hereby amended in that the name of the Corporation is changed from EBI OF NORTH FLORIDA, INC. to GLOBAL NETWORK SOLUTIONS, INC. To effect this change, the heading and Article I of the Articles of Incorporation of the Corporation are hereby amended, insofar as they refer to the name of the Corporation, to read GLOBAL NETWORK SOLUTIONS, INC. in lieu of EBI OF NORTH FLORIDA, INC.

The proposed amendment of the Articles of Incorporation as set forth in Paragraph 2 hereinabove was approved on August 7, 1998 by written consent of the sole director of the Corporation and the sole shareholder of the Corporation owning all of the voting stock of the Corporation. The number of votes cast by such voting group was sufficient for approval by that voting group.
