The undersigned incorporator, CHARLES VARNEY, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is APPRAISALS BY THE C, INC., whose corporate principal office is 343 Varella Avenue, St. Augustine, Florida 32095.

ARTICLE II NATURE OF BUSINESS


